Hard hats are compulsory when riding anywhere on the show grounds. Junior competitors must wear properly fitted, approved protective headgear with the safety harness correctly secured at all times while mounted or riding on a horse-drawn vehicle on the Competition or event grounds. Juniors showing any horse/pony in a jog for soundness must wear approved protective with the attached safety harness fastened. Approved headgear must be certified by SEI or another testing body that it meets the American Society for Testing Materials (ASTM) standard or the British Standards Institution (BSI) standard.

PLEASE READ CAREFULLY BEFORE SIGNING (INCLUDES RELEASE AND INDEMNITY AGREEMENT)

By submitting this entry to the Royal Agricultural Winter Fair ("RAWF"), the undersigned, owner, lessee, trainer, manager, coach, exhibitor, driver, rider, and any other agent or representative of the entered horse(s) ("Exhibitors") agree to abide by the rules and regulations of the RAWF, including the Code of Conduct, and the constitution and rules of Equestrian Canada. Copies of the Rules of Equestrian Canada are available online at www.equestrian.ca. The undersigned will ensure that Exhibitors are familiar with and comply with the above noted requirements. The undersigned acknowledges that failure to adhere to these requirements could result in suspension or ban of Exhibitors or horses from the RAWF and other disciplinary measures. The undersigned warrants that every horse, rider, handler and driver is eligible as entered.

As a condition of acceptance of entry, Exhibitors give the RAWF an irrevocable right and permission to publish, market, transfer, assign, or otherwise make use of any photographs, likenesses, films, broadcasts, audiotapes, or videotapes taken of the horse(s) and Exhibitors while on the grounds, so long as the use does not jeopardize amateur status. Exhibitors further expressly and irrevocably waive and release any rights in connection with such use of photographs, likenesses, films, broadcasts, audiotapes, or videotapes, including any claims for invasion of privacy, right of publicity, misappropriation, or libel.

The undersigned hereby releases the RAWF, Maple Leaf Sports & Entertainment Ltd., Enercare Centre/The Board of Governors of Exhibition Place, sponsoring organizations, and their directors, officers, successors, assigns, employees, agents, and all persons acting on their behalf (the "Releasees") from any and all claims and demands whatsoever which may arise in connection with any inspection or disqualification of this entry and from any and all claims and demands whatsoever for any damage, injury (including death), loss, cost, or theft, however caused relating to this entry, or suffered by the undersigned, its employees, and agents while on the grounds of the RAWF.

I hereby certify that every horse, rider and/or driver is eligible as entered and agree for myself and my representatives to be bound by the Constitution and rules of Equestrian Canada at this competition. It is hereby recognized that all equestrian sports involve inherent risk and that no helmet or protective equipment can protect against all foreseeable injury. I hereby accept this risk and hold harmless EC, the competition, their officials, organizers, agents, employees, and their representatives. The person responsible (PR) agrees to the release of any information on the entry form to EC.

The undersigned further agrees to indemnify and hold harmless the Releasees from any and all claims and liability for loss, damage, injury (including death), expense, or theft, to any person or property caused or contributed to by the Exhibitors or the horse(s) herein entered. The undersigned also certifies that all horses entered are healthy and free of communicable disease.

The laws of Ontario govern this agreement and any legal proceedings must be commenced and litigated in the Province of Ontario.
