

SCHEDULE C

GLOSSARY OF DEFINED TERMS

The following terms are used in the Commercial Exhibit *Licence Agreement*, including its schedules, the Regulations, Rules & Requirements of the RAWF and the General Information section, of the RAWF's Commercial *Exhibitor Kit*.

Approved Exhibit means the goods, services and products listed in Schedule A to the *Licence Agreement* as approved by RAWF for exhibition and/or sale by the *Exhibitor* during *The Royal*, and includes the structure and/or method for display of said goods, services and products as stipulated in that Schedule A.

Exhibit Space means the space consisting of Booth number, Hall, Size, Cost, and HST. *Exhibit Space* means that space as defined in the *Licence Agreement* as licensed to the *Exhibitor*.

Exhibition Place means the lands and premises generally known and referred to as, *Exhibition Place* and/or the Enercare Centre.

Licence Agreement means a Commercial Exhibit *Licence Agreement* entered into between the *Exhibitor* and RAWF for the licensing to the *Exhibitor* of an *Exhibit Space*.

Licensing Date means the date upon which this *Licensing Agreement* is signed and dated by both *Exhibitor* and RAWF.

Licence Fees means the total sum including Harmonized Sales Tax and any other applicable taxes, all of which is payable in Canadian funds by *Exhibitor* for the licence hereby granted for use of the *Exhibit Space (Licence Agreement)* as payable by the *Exhibitor* for the licence granted.

Move-in Time means the date and time that will be stipulated by RAWF during which *Exhibitors* must set-up their *Approved Exhibit* in their *Exhibit Space*.

Move-out Time means the date and time that will be stipulated by RAWF during which *Exhibitor* must remove their *Approved Exhibit* from the *Exhibit Space*.

Final Pick-up Time means the date and time that will be stipulated by RAWF by which *Exhibitors* must claim any of their property remaining on *The Royal* or *Exhibition Place* premises.

RAWF means *The Royal Agricultural Winter Fair Association of Canada*

The Royal means the 2020 Royal Agricultural Winter Fair to be held by RAWF from November 5th-15th, 2020 at the Enercare Centre, *Exhibition Place*, Toronto, Ontario.

Rules, Requirements, & Regulations means the Commercial *Exhibitor Rules, Requirements & Regulations* included in *The Royal Exhibitor Manual*, online *Rules, Requirements and Regulations* and the *Commercial Exhibitor Online Kit* at <https://www.royalfair.org/commercial-exhibitors/> and may be amended by RAWF from time to time.
